DURING 2022, 534 FAMILIES CONTACTED ANGELS TO INQUIRE ABOUT THE FOSTER PROGRAM. 151 FAMILIES ATTENDED ORIENTATION AND 45 OF THESE SUBMITTED APPLICATIONS. 25 OF THESE FAMILIES COMPLETED TRAINING. 13 FAMILIES WERE CERTIFIED IN 2022. 45 CHILDREN WERE PLACED IN THE ANGELS FOSTER CARE PROGRAM DURING 2022 AND 2 WERE TRANSFERRED TO THE ISFC PROGRAM AND 61 CHILDREN WERE DISCHARGED FROM OUR CARE OF WHICH 3 WERE AT THE ISFC RATE. 111 CHILDREN WERE SERVED DURING 2022 IN THIS PROGRAM WITH 6 MORE SERVED AT THE ISFC RATE.
