DURING 2021, 1,125 FAMILIES CONTACTED ANGELS TO INQUIRE ABOUT THE FOSTER PROGRAM. 270 FAMILIES ATTENDED ORIENTATION AND 46 OF THESE SUBMITTED APPLICATIONS. 29 OF THESE FAMILIES COMPLETED TRAINING. 25 FAMILIES WERE CERTIFIED IN 2021. 56 CHILDREN WERE PLACED IN THE ANGELS FOSTER CARE PROGRAM DURING 2021 AND 2 WERE TRANSFERRED TO THE ISFC PROGRAM AND 56 CHILDREN WERE DISCHARGED FROM OUR CARE. 112 CHILDREN WERE SERVED DURING 2021.
